### What is Ship-Chic?

Ship-Chic Craft & Vintage Shows are curated indoor pop-up markets that feature amazing products for DIY lovers, Pinterest obsessers, Etsy loyalists, creative gift givers, small business supporters, or just folks who want a unique holiday shopping experience! Old stuff, new stuff, and awesome stuff - all picked with quality in mind. Shopper admission is \$5 at the door before 12 pm, and \$3 after 12pm. Children 12 and under are free and parking is free. The shows are professionally managed, organized and promoted by the seasoned staff at Shipshewana Trading Place Auction & Flea Market.

### Isn't Shipshewana an awesome town to host a craft & vintage show?

Why yes, yes it is. Shipshewana, Indiana is a high-traffic tourist town in the heart of Northern Indiana's Amish Country. The Ship-Chic show is held inside the heated and enclosed Shipshewana Auction Misc. & Antique Building at 345 S Van Buren St (S.R. 5).

### Where are you advertising?

Good question! Our marketing team uses a variety of print, web, social, video, co-op ads, and radio promotions to get the customers you desire to shop your booth. Accepted vendors will be provided with an advertising kit and instructions on linking to our social media through email.

## VENDOR INFORMATION

### Here's the low-down on how to apply:

1. Fill out the attached application completely.
2. Gather at least 3 photos of your items or of a past show display.
3. Send in payment for your space. Make checks out to Shipshewana Auction, Inc. Payments made over the phone with credit card are also accepted but will incur a \$5.00 charge.
4. Email your application and photos to [michael@shipshewanatradingplace.com](mailto:michael@shipshewanatradingplace.com), or snail mail it to: Shipshewana Trading Place, c/o Ship-Chic Show, PO Box 185, Shipshewana, IN 46565.

**\* Vendor admittance will be considered only after receiving the completed application with requested photos and payment. \***

### How much for a booth?

Vendor rent is \$65 per space. Choose between an 8' x 10' wall space or a 10' x 10' inside space. Vendors will need to stay within the boundaries of the area provided and must keep all exit/entrance ways clear. Electricity is available for \$10. Tables are 6' or 8' and are available for \$10 each. We suggest bringing extension cords and/or skirting if renting electricity or tables.

### How does set up work?

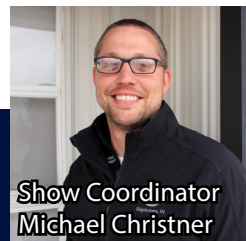
Vendors will check in and set up the Friday prior to the show, 10 am -6 pm, and on Saturday, 7 am - 8:30 am. Limited hand carts and dollies will be available for use while unloading. Booths are to remain open during show times (9 am - 3 pm). Breakdown of displays can begin promptly at 3 pm.

### Other important Ship-Chic schtuff

Reserved parking will be available for vendors. From out of town? Overnight accommodations are available across the street at the Farmstead Inn (260-768-4595). Accepted vendors will receive a discount code for Farmstead Inn lodging, free vendor Wi-Fi, and two complimentary Ship-Chic show admission tickets to give away. (Please note: Complimentary tickets will only be given to vendors who are accepted prior to the week of the show date.)
