- Shipshewana Trading Place has the right to reject any article to be offered for sale. No guns, gun parts or live ammunition are to be offered for sale. This includes black powder, starter guns or any other type of firearm. Toy guns may be offered such as cap guns or any other type of toy gun.

#### **Cancellation Policy:**

All vendor applications that have been received, processed and accepted must cancel 45 days in advance of show to receive a refund of paid fees over the \$20 non-refundable deposit.

#### Early Packing

#### Facilities

Restrooms are available in the Misc. & Antique Auction Building. This is an indoor market with an open-air feel in the barn. Air-conditioning is not provided, however, it is covered and usually pleasant with the doors open. Please plan accordingly. Food will be available.

#### Security

The Shipshewana Antique Market provides security during the market time. However, Shipshewana Antique Market cannot be responsible for breakage or damage of any kind or for lost or stolen merchandise.

#### Trash & Cleanup

Dealers are responsible to keep their space clean at all times. Please tidy up your spaces and put small trash in barrels.

#### Lodging

Lodging is available across the street at our Farmstead Inn & Conference Center (call 260-768-4595) or at the Shipshewana RV Park (call 260-768-7627).

#### General Information

Vendors must register both personal and business (if any) name, address and a copy of their State of Indiana Registered Retail Merchant Certificate with the office. Each vendor is required to collect 7% sales tax for the state of Indiana - no exceptions. If you need to register for a tax number, go to <https://inbiz.in.gov> or contact the Indiana Dept. of Revenue at 317-234-9768.

Any person who conducts themselves in an objectionable manner, including consummation of alcohol, drugs, foul language or any other action not conducive to a respectable market, or is not marketing antique or vintage items is subject to be removed from the premises.
